1. Safety Moment

8. Planning and Development

a. 1 Alma Avenue – HBB – Massage Therapy

The Committee directed staff to proceed with the Notice of Discretionary Use for a Home Based Business at 1 Alma Avenue and to send to Council with a recommendation to approve subject to no objections being received in response to the Notice and 10 conditions. If objections are received, the application will be returned to the Committee for further discussion.

f. 59 Trails End Drive – Fence Setback

Committee discussed an application for a proposed fence setback at 59 Trails End Drive. The application was referred to the Public Works Committee. The Public Works Committee recommended unanimously that the fence be setback 3.0m from the property boundary and that Council refuse the application for the fence to be located 3.0m from the curb along the flanking street. Prior to sending a recommendation to Council, the PPS Committee directed staff to reach out to the applicant regarding the option to re-apply for a fence that meets the recommended 3.0m from the property boundary.
