6. Municipal Plan and Regulations Policy Initiatives and Amendments

a. Town of Portugal Cove-St. Philip's Request to Amend SJURRP

Committee discussed the Town of Portugal Cove-St. Phillip's Request to amend SJURRP. Committee recommended no objections be submitted or further comments since the proposed amendment seems to have no or minimal impact on the region, particularly the Town of Paradise.

b. Plan Amendment #3 Development Regulations #19 (Market Ridge)

Staff provided the committee with an update on Plan Amendment #3 Development Regulations #19 (Market Ridge).

c. Development Regulations #20 (Greenhouses)

Staff provided Committee with an update on Development Regulations #20 (Greenhouses).

d. Plan Amendment #4 Development Regulations #21 (Moonlight Drive)

Staff provided Committee with an update on Plan Amendment #4 Development Regulations #21 (Moonlight Drive).

e. Development Regulations #18 (Market Ridge Apartments)

a. Community Collaboration Grant Approval (for Advantage St. John's branding)

8. Municipal Enforcement

a. 50 Donna Road – Wood Stove Appeal Hearing

Staff provided the committee with an update on the appeal of an Order regarding a wood stove in an accessory building. The Appeal Adjudicator ruled in favour of the Town and upheld the Order.

b. 16 Father Lacey Place

Committee discussed the fire damage to 16 Father Lacey Place.

9. Planning and Development

a. Building Permits Jan 23 - Feb 5

Committee discussed the permits issued between January 23 and February 5, 2024.

b. 13 Ungava Street

Committee discussed a compliance request for an accessory building located at 13 Ungava Street. The accessory building location does not meet the required 1.2 m from the side boundary and would require a 10% variance to the standard. The Development Regulations does not prohibit variances to the 1.2 m standard; however, the standard practice has been not to approve. Committee recommend advertising the variance and Council approve subject to no objections being received.

c. 1717 Topsail Road – Boathouse, wharf, slipway, concrete walkway on Crown land

Committee discussed 1717 Topsail Road and recommend proceeding with the Notice of Discretionary Use and Council approval subject to four conditions.

d. Potential Impacts of Tourist Accommodations Act and Regulations on Town of Paradise

Committee discussed the potential impacts of the Tourist Accommodations Act and Regulations. Committee requested staff collaborate with other relevant departments, including Finance, and conduct further study on the matter.
