## 3. Adoption of the Minutes

## 4. Business Arising from the Minutes

Committee asked for an update on 7c from December 9, 2021 meeting. There was no new information to report.

## 5. Municipal Plan and Regulations Policy Initiatives and Amendments

## a. Amendments

MPA 02-2020 and DRA 08-2020 – *Fairview Investments Unserviced Development* - A Commissioner for the Town's public hearing was selected. A summary of consultation was provided to the Province.

Family and Group Homes – There are no updates at this time.

**Proposed PMDC Rezoning** – The Town is waiting for more information from the Developer.

Municipal Plan and Development Regulations Amendment 1, 2019 –
Close File The Amendment is still under review.

## c. DRA 10, 2022

The Committee reviewed the report. The Amendment would apply to all new streets and create an improvement to the streetscape. Committee recommend that Council proceed with public consultation in accordance with the requirements of the Urban and Rural Planning Act, 2000.

#### a. Sullivan's Road Subdivision

## b. 8 Donna Road Subsidiary Apartment

An application was received for a subsidiary apartment in the dwelling located at 8 Donna Road situated in a Residential Low Density (RLD) use zone. Committee recommend proceeding with the Discretionary Notice Advertisement and approve the application subject to no objections being received.

# c. 1269 Kenmount Road Industrial Building and Proposed Road Cut

Committee reviewed the report and recommend upholding the Town's Road Cut Policy and defer approval of this application.
