#### 5. New/Other Business

#### a. Paradise Elementary Active NL

The Department of Tourism, Culture, Arts and Recreation has approved a grant for Paradise Elementary Active NL.

## b. **Boathouse and Heritage**

The committee reviewed correspondence from Mr. Whitelaw's regarding the construction of furniture for the new boathouse that would incorporate salvaged wood from the former building on 1717 Topsail Road. The committee recommend staff continue discussions with Mr. Whitelaw.

#### c. <u>Boathouse Public Engagement</u>

Staff and the Avalon Dragons began discussions with consultants regarding the construction of the new boathouse. The committee recommendation was to close the public engagement and review the responses that were received.

## e. Boathouse Memorandum of Understanding
