The installation of water and sewer service would be in contravention of the Town of Paradise Development Regulation #40 which states:

"Accessory Buildings are permitted in each use class provided the buildings are clearly incidental and complimentary to the main building's character, size, and use. The buildings must be located on the lot on which the main building is located except as provided for under the Conservation Use Zone in Schedule C of these Regulations. Accessory buildings are not permitted to be used for human habitation..."

By permitting the installation of water and sewer services to the accessory building would be permitting the use of human habitation, therefore would not be in accordance with the Town of Paradise Development Regulations 2004.

The Town of Paradise considers the installation of a washroom facility in the accessory building (garage) as "human habitation" of an accessory building therefore is contrary to Regulation #40 of the Town of Paradise Development Regulation 2004.

The proposed extension was referred to the City of St. John's in accordance with Section 2 of the Town of Paradise/City of St. John's Watershed Agreement and condition #4 of the Residential Watershed Use Zone of the Town of Paradise Municipal Plan & Development Regulations, 2004 which states that "all development applications will be referred to the City of St. John's for approval."

The City rejected the application at the Regular Meeting of the St. John's Development Committee (copy attached). As such, the proposed development is deemed to be in contravention with the Town of Paradise Development Regulations, 2004, specifically Section 6 which states, "Development shall be carried out in accordance with the Municipal Plan, these Regulations, and the conditions stated in a Permit to Develop".

2. Section 104 and 106 of the City of St. John's Act states that the City of St. John's has the discretionary power to allow development in specified circumstances. The City of St. John's is not prepared to exercise its discretionary powers in order to permit the proposed development. It is the City of St. John's policy that the proposal is contrary to Sections 104 & 106 of the City of St. John's Act which prohibits development in the watershed.
