1. M13-147 Moved by Councillor Bobbett, seconded by Deputy Mayor English to approve application of 65158 Newfoundland & Labrador Ltd. (Gary Mahon), DA13-0143, for development approval for Phase 8 of Paradise Ridge Subdivision subject to twelve (12) conditions.

- 2. M13-148 Moved by Councillor Burton, seconded by Councillor Bobbett to refuse application of Bernard Downey, DA13-0320, to install a fence in the front yard at 1506 Topsail Road as the installation of the fence would be in contravention of the Fence Regulations #11 & #13(1) which states:
 - 1. Fence Regulation #11: "Clear View"

"No fence shall be permitted to be erected that obscures a clear view of street intersections, pedestrian pathways, driveways or other points of access or egress of vehicles or pedestrian traffic."

2. <u>Fence Regulation #13(1)</u> "Residential Lot - Front Yard"

"A fence is not permitted in the front yard of any lot that is considered by the Town of Paradise to be a 'fully serviced lot'."

M13-149 Moved by Councillor Burton, seconded by Councillor Willis to refuse application of Ed Quilty, DA13-0377, for approval of a residential building lot at 1 Deborah Lynn Heights as the proposed development does not meet the requirements of the RMD zone in relation to the required lot area and building line setback (St. Thomas Line), and would be in contravention with General Regulation #6 which states:

"Development shall be carried out in accordance with the Municipal Plan, these Regulations, and the conditions stated in a Permit to Develop."

4. M13-150 Moved by Deputy Mayor English, seconded by Councillor Willis to refuse application of Edmund Hynes and Kelly Hilscher, DA13-0336, to subdivide land for a residential lot at 116 Duff's Crescent for the following reasons:

The property is located within a Residential Low Density Use zone in which the required frontage is 18.0 m. The proposed subdivision of the property at 116 Duff's Crescent would reduce the street frontage for the remaining property to 6.016 m.

The application is therefore refused in accordance with General Regulation 6 and General 48(1) of the Town of Paradise Development Regulations, 2004 which states:

General Regulation 6 "Compliance with Regulations" – "Development shall be carried out in accordance with the Municipal Plan, these Regulations, and the conditions stated in a Permit to Develop."

General Regulation 48(1) – "No lot shall be reduced in area, either by conveyance or alienation of any portion thereof or otherwise, so that any building or structure on such lot shall have a lot coverage that exceeds, or a front yard, rear yard, side yard, frontage or lot area that is less than that permitted by these Regulations for the zone in which such lot is located."

5. M13-151 Moved by Councillor Willis, seconded by Councillor Quilty to approve application of Laurmax Developments, DA13-0496, to develop four additional lots in Phase 3 of Grand Meadows Subdivision subject to five (5) conditions.
