Greater than 1860 but less than 3600	7% of the lot area or 70 sq m whichever is lesser	4.5 m
3600 or greater	90 sq m	4.5 m
3600 or greater	At Council's discretion to approve an accessory building to a maximum of 150 sq m.	4.5 m

As the applicant's property has less a lot area than 3600 m², the proposed total accessory building floor area of 116.6 m² exceeds the permitted floor area of 70 m².
