 - 1. The Town of Paradise (RWS) Residential Watershed Zone standards require a lot depth of 32 meters. The proposed lot does not meet the minimum requirement and the development, therefore, is contrary to the Town of Paradise Development Regulations 2004.
 - The Town of Paradise (RWS) Residential Watershed Zone Condition 4 states:

"Under the provisions of the Watershed Agreement in place between the Town of Paradise and the City of St. John's, all development applications will be referred to the City of St. John's for approval."

The application was referred to the City of St. John's on October 14, 2014. The City of St. John's responded on November 28, 2014 and refused the proposed under the City of St. John's Act.

3. The proposed development is not in accordance with the Town of Paradise Municipal Plan & Development Regulations, 2004, specifically Section 6 of the General Regulations: Compliance with Regulations, which states:

"Development shall be carried out in accordance with the Municipal Plan, these Regulations, and the conditions stated in a Permit to Develop".
