## 6. **PERMITS:**

- 1. M14-325 Moved by Councillor Burton, seconded by Councillor Laurie to refuse application of Brian Walsh, DA14-0708, to house 2 goats and up to 24 chickens at 125 Buckingham Drive in accordance with Section 10 of the Town of Paradise Development Regulations, 2004 and the following reasons:
  - (1) A significant number of objections were received in response to the advertised Discretionary Use Notice. Council, therefore, has determined that the keeping of the animals (pygmy goats and fowl) on the property is not in keeping with the amenity of the area.
  - (2) Council has determined that the keeping of the goats and fowl may cause increase of rodents in the area causing an issue for public safety.
  - (3) The roosters natural crowing is considered a nuisance by neighbouring residents. The keeping of roosters is a considered nuisance due to the natural crowing noise produced by the animals.
  - (4) An inspection of the property found the property to be untidy with a significant amount of dog faeces, overturned feed containers, etc. Council has determined that the keeping of goats and fowl would only increase the onsite issues with the property.
