- General Regulations 21(5) of the Town of Paradise Development Regulations, 2004 states "The Council may revoke a Permit to Develop for failure by the developer to comply with the Municipal Plan and these Regulations, or any condition attached to the Permit to Develop, or where it was issued in error or was issued on the basis of incorrect information." Council determined that the permit was issued in error as permission was not obtained from all property owners.
- The Urban and Rural Planning Act defines "Building" and "Development" respectively as follows:
  - "Building means a structure, erection, alteration or improvement placed on, over, or under land or attached, anchored or moored to land,"
  - "Development means the carrying out of building, engineering, mining or other operations in, on, over or under land, ….."
