42. Landscaping and Screening

- (1) The Council may require landscaping and screening for a proposed development in order to provide;
 - (a) screen or separation between different or incompatible uses, principally between residential and non-residential uses, which will consist of either a screen of a minimum height of 1.8 metres, or a buffer of 10 metres.
 - (b) an acoustic barrier,
 - (c) an attractive visual continuity and appearance between developments or on an individual site,
 - (d) delineation of an area, and
 - (e) protection for the natural environment.
- 2) The application is considered to be contrary to the Town of Paradise Policy on Landscaping, 2007 in particular Landscaping Conditions # 1 and # 2 as outlined below:
 - 1. The Town of Paradise requires, as a minimum, that the front of all new developments be landscaped. Such landscaping shall extend from the front building line to the inside of the curb. Where no curb is present the landscaping shall extend to the bottom of the inner ditch slope. The landscaping shall be completed on both the facing and flanking streets for corner lots.
 - 2. The landscaping shall consist of a lawn, seeded or sodded, with good overall growth, trees, scrubs, etc, and any other landscaping materials providing the front yard has a clean and tidy appearance. The Town of Paradise will at its own discretion determine whether or not the landscaping is approved under this policy.
