Therefore the application is deemed contrary to the Town of Paradise Development Regulations, 2004 and the Town of Paradise Municipal Plan 2004 for the following reason:

The existing accessory building as constructed in its current location has an existing set-back of 0.34m from the rear yard lot line. This set-back does not comply with the minimum required rear yard set-back of 1.2m. Therefore the accessory building's location is deemed to be non-compliant with Section 40(2)(a)(i)(1) of the Town of Paradise Development Regulations, 2004 outlined below:

"40. Accessory Buildings

(2) <u>Residential (Other than the Residential Watershed Zone)</u>

Accessory buildings shall be permitted in the Residential Land Use Zones, with the exception of the Residential Watershed Land Use Zone, in accordance with the following:

- (a) Location on Property
 - i) Accessory buildings shall not be located:
 - 1. Within 1.2 m from any property boundary;
 - 2. 2.4 m from any building; and,
 - 3. Within any easement area."
