She noted that there there will be many activities, such as face painting, Sky High Amusements, free hot chocolate, and prize giveaways.
- 3. Councillor Quilty commented that residents should be very pleased with no increases in fees or taxes in the recent budget.
- 4. Councillor Dinn, Chair of the Finance Committee, thanked all staff who helped and assisted in the preparation of the 2018 Budget. He noted that Council made sure that the Finance Committee did not miss any considerations expressed to Council in the Fall and through the Town's survey. Councillor Dinn added that the Town allocates so much in our budget for a number of items but continues to look for additional funding elsewhere to save the Town money from its coffers.
- 5. Councillor English commended Councillor Dinn and the Director of Corporate Services for their part in the budget preparation.
- 6. Councillor Martin stated a great job for a balance budget.
- 7. Mayor Bobbett stated that the balance budget was a result of all departments working together, with deductions in every department, and keeping the interest that every dollar we spend is taxpayers' dollars.
- 8. Councillor Willis asked if there was anything new to report on the History App. The Director of Corporate Services responded that the Town has gathered the information over the summer and will continue to work on the app in the new year.
