- Councillor Dinn recommended that Council open up talks again with the City of St. John's in regard to the Watershed Agreement and revisit Mr. Lynch's application for a permit to construct a bathroom at the back of his garage.

- 3. Councillor Dinn requested that Council, in the future, discuss extending sidewalks along Topsail Road.

8. **NEW/UNFINISHED BUSINESS:**

- 4. Councillor Dinn asked if Planning Committee could revisit the development application of a property owner on Sherbrooke Street who would like to backfill his lot level to his neighbour's lot until he is ready to build. Mayor Bobbett asked Councillor Quilty to add this request to the next Planning Committee Agenda.
- 5. Councillor English commented that at the Municipalities Newfoundland & Labrador Convention that he recently attended, a resolution to request the Province to include project management costs as part of cost shared arrangement was defeated by the participants at the convention. He said that the discussion he heard related to the fact that it appears to add an additional burden to the cost of the project and probably should be done in-house.

Mayor Bobbett responded that those costs are already included and clarified that the Motion was to make it mandatory to have a project engineer.

6. Councillor English asked to have a copy of the most recent internal financial statements. The Director of Corporate Services will provide Councillor English with the financial statements.

Councillor English said he applauded the idea of going to a zero-based budget. He stated that one particular cost that stands out to him is the Projective Operating Loss for the community centre and stated he would like this to be addressed in the 2018 Budget.

7. Councillor English questioned Mayor Bobbett's statement that he made in the Shoreline that a new Town Hall was not under active consideration, when Council in April 2017 approved a submission to Municipal Affairs for funding under the Building Canada Fund, including \$22,956,000 for a new Town Hall.

Mayor Bobbett responded that Councillor English, as a former Chairman of the Finance Committee, should understand how funding requests work with towns submitting their lists of items, not all of which get approved. He added that while the Town did include the Town Hall request on its list of capital projects, it was contingent upon the economy being able to support it. In the end, Council opted to renovate the existing Town Hall rather than pursue a new one.

Councillor English suggested Council revise its priority list. Mayor Bobbett directed that request to Councillor Dinn, the Chair of Finance for the next Finance Committee meeting.

- 9. Councillor Willis commented that construction on Sunvalley Drive will hopefully be finished this week or next, weather permitting.
- 10. Councillor Willis stated that the resurfacing of Paradise Road from Milton Road to Stormont Street will be done in the Spring.
- 11. Councillor Willis informed Council that the senior's bowling and shuffleboard programs are doing very well with many participants.
- 12. Councillor Willis relayed a safety tip to residents to not hire workers to do household repairs, etc. that are not business affiliated and are not covered under the Workers' Compensation Board as the resident will be liable if the worker is injured.
- 13. Councillor Quilty reminded Council of the Town's War Memorial Service on November 11, 2017.
- 14. Councillor Quilty informed Council that she will be withdrawing her nomination for Urban Region Director of the Municipal Assessment Agency.
- 15. Councillor Quilty passed along her condolences to the family of Fred Neil. She remarked that Fred was an amazing volunteer and was a true ambassador for the Town of Paradise.
- 16. Councillor Martin thanked Town staff and the Scouts for a well-planned and enjoyable Guy Fawkes Night.
- 17. Councillor Dinn asked how residents are informed about Council decisions that are made in the Committee of the Whole meeting but not in the Public Council meeting. The CAO responded that staff will always get back to the resident with the decision of Council the next day.
