Development Regulations – images throughout the document have been revised and clarified.

Section 2 Definitions – Child Care (Family) has been revised to allow for seven (7) children as per recent changes to the Child Care Act.

Regulation 4.6 Building Line and Setback – has been revised to clarify the regulation by adding 4.6(3) 'Notwithstanding the Building Line Setback in any Zone in Section 9, the Town may require an increased Setback on Topsail Road, St. Thomas Line and Paradise Road in accordance with the requirements of the Engineering Department'.

Regulations 4.20 Shoreline Buffers – has been revised to change 4.20(1) from '60m of Octagon Pond' to '30m of Octagon Pond' and add 4.20(3) 'Council may require an assessment of the visual impact of a development on the Octagon Pond walking trail and the implementation of measures it considers necessary to protect the integrity of the trail and the surrounding treed buffer'.

Regulation 9.21 Commercial General (CG) – has been revised to add Place of Worship as a permitted use.

Regulation 9.22 Commercial Main Street (CM) – has been revised to add standards for Single-detached Dwellings (existing) to Regulation 9.22(5) which states 'Development standards for Single-detached Dwellings (existing) shall be the same as those set out in the Residential Medium Density Use Zone'.

Regulation 9.29 Commercial Neighbourhood (CN) – has been revised to clarify 'Market' as 'Outdoor Market'.

Appendix B Classification of Uses and Building – has been revised to remove Family and Group Home from an example under Residential Dwelling Uses.

Land Use Zoning Map

- 12 Paradise Road has been rezoned from Residential Medium Density (RMD) to Residential Mixed (RM).
- The Conservation (CON) zone around Octagon Pond has been reduced to 30m.
- The Conservation (CON) zone along Topsail Bluff has been edited to reflect 30m from the cliff's edge.
- Minor adjustments to better reflect property boundaries.
- 20 Karwood Drive to be zoned Residential High Density (RHD)."
