3. Councillor Quilty gave an update on the ongoing construction projects.

### Karwood Drive:

The finish top course of asphalt is scheduled to be placed on Thursday, weather pending. A public service announcement for the work will be going out Wednesday.

### McNamara Drive/Topsail Road

All underground work on McNamara Drive, except that within the intersection of Topsail Road has been completed. The base course of paving on all areas outside of the roundabout is scheduled to be completed on Saturday, June 22. A number of factors, including weather, may delay the paving from taking place on this date. Work on the roundabout with Topsail Road is progressing as planned. Some underground work is going to be performed this week. The lights will be turned off during construction hours and traffic will be controlled by flags people. There are 2 lanes scheduled to be maintained in the directions of rush hour traffic and a single lane in the opposite direction. Traffic light control will be in service outside of construction hours.

### Clearview Heights

Work on the installation of the storm sewer and the road upgrades are continuing.

### Paradise Road

Work is progressing and there is an additional crew scheduled to speed progress along. Significant and unavoidable delays can still be expected in the area. Paradise Road access to and from local roads will change daily as the project progresses. The Town has asked the contractor for more notice for the residents when turning restrictions are required.

### O'Brien's Way

Construction is underway. The addition of the temporary stream crossing and road diversion is next to be completed to allow further work to proceed.

Other Projects

- Joshua Street has been completed.
- Summit Drive is planned to have finish course of asphalt installed tomorrow.
- Sullivan Place, Pretty Place and Brandywind Place will be getting finishing touches as weather and scheduling permit.
- 4. Councillor Quilty informed Council that she attended the Paradise Pre-School Graduation on behalf of Mayor Bobbett.

- 5. Councillor Quilty informed Council that she attended the Rotary Event on behalf of Mayor Bobbett.
- 6. Councillor Street noted that it was mentioned on the news today that there would be more police presence observing dirt bike usage.
- 7. Councillor Street had a resident from Carlingford Street concerned about dirt being dropped off to an empty lot that is undeveloped. CAO Niblock responded that staff are looking into this.
- 8. Councillor Street informed Council that she has been getting a number of calls about wooden garbage boxes still located on property fronts throughout the Town. Is there a regulation stating that they are to be removed? CAO Niblock responded that any garbage boxes that were in the right of way have been removed but any that remain are on private property and staff are looking into it. Some residents wanted to keep their wooden boxes so they moved them out of the right of way.
- 9. Councillor English inquired on when a financial update will be provided. Director Smith responded that this is in progress and the intent is to have it completed for the Finance and Administration meeting in July.
- 10. Councillor Willis informed Council that he attended the Special Olympics Torch Run on behalf of Mayor Bobbett.
- 11. Councillor Quilty reminded Council and residents that the Memorial Day Ceremony is taking place on July 1 beginning at 10:55 am. Following that ceremony there are events taking place in the afternoon and evening in observance of Canada Day.
- 12. Councillor Willis inquired about the progress of the line painting within the Town.

Deputy Mayor Laurie declared a potential conflict of interest because her sister owns the company hired to complete the line painting within the Town.
