# NEW/UNFINISHED BUSINESS:

- 1. Councillor Quilty provided an update on upcoming construction projects. There are 3 roads that were serviced with water and sewer last year, Pretty Place, Brandywind Place and Sullivan Place. These streets will be completed this year. The servicing on O'Briens Way will begin this year. The road work that is scheduled to start in June is by McDonalds on Topsail Road, the roundabout at Topsail Road and Clearview Heights and upgrades to Paradise Road and Clearview Heights. Mayor Bobbett advised residents to continue to monitor the Towns website and social media for updates on roadwork and road closures.
- Councillor Martin informed Council that the Scouts are having a Cub Car Rally on Saturday in the gymnasium of the RPYCC from 9:00am-4:00pm. Council are invited to attend.
- 3. Councillor Martin asked how many people are utilizing the PingStreet app. Mayor Bobbett said that he would follow up with Communications.
- 4. Mayor Bobbett took an opportunity to promote recycling within the Town. He reminded Council that it is \$21 a tonne for recycling bags and \$67 a tonne for garbage bags.
- 5. Mayor Bobbett reminded the residents that the ponds are breaking up and cautioned people to not be on them.
- 6. Deputy Mayor Laurie discussed the speeding issues around Elizabeth Park Elementary that were included in the March 5 meeting. She has had positive feedback from residents since that time regarding increased RNC Patrol. She reminded residents to pay particular attention to children walking to school.
- 7. Deputy Mayor Laurie encouraged residents to consider putting their name forward for nomination for the upcoming By-Election.
- 8. Deputy Mayor Laurie shared her experience at the Gauging Women's Presence Conference that she recently had the opportunity to attend. She was invited to be a panelist in the session on Women in Municipal Politics: The Experiences of Elected Officials.
