## 7. CORRESPONDENCE:

#### MNL AGM Call for Resolutions

Mayor Bobbett reminded Council to submit any resolutions they would like to have discussed at the upcoming MNL AGM. The deadline for submissions is September 13, 2019.

### 8. **NEW/UNFINISHED BUSINESS:**



 Councillor Street has been in contact with a resident regarding dissatisfaction of lack of water and sewer hookup in his area and issues that he has regarding it. He has since been in contact with CAO Niblock and he would like to work with the Town to work on better practices for notifying residents on developments and construction.



 Councillor Street requested an update on the repairs on Summit Drive. Also, the residents have asked if a sign could be posted restricting heavy equipment as it is causing a lot of damage to the street. Mayor Bobbett advised that this will be looked into further at the Infrastructure and Public Works Committee.



3. Councillor Street thanked Director Milley for following up with a resident that was concerned about the cracks in the sealing of Town Roads. Councillor Street stated that she is pleased that a road maintenance program is being considered for the 2020 budget.



4. Councillor Street expressed concerns from residents regarding the Metrobus routes and accessible transportation. Residents expressed that the routes need to be expanded and also that there be affordable accessible transportation available for the residents. Mayor Bobbett responded that this will be at committee.



5. Councillor Street expressed safety concerns from the residents of Christopher Street with regards to 1664 and 1676 Topsail Road. The residents are concerned because there are no street signs and there is damage to the road in that area. Mayor Bobbett responded that this would be discussed at the Infrastructure and Public Works Committee meeting. 6. Councillor Street has been contacted by residents regarding the conditions around the plaza at 1300 Topsail Road. There is an excessive amount of garbage around the area that needs to be cleaned up. Residents have asked that the businesses in the area be held accountable to keep the areas clean. Mayor Bobbett responded that this will be discussed at committee.



7. Councillor Street was contacted by a resident that wants to set up a temporary tent. The resident has spoken with the Town and requested approval but this request is time sensitive. The resident is looking to host meetings starting the end of August. CAO Niblock responded that she has been in discussion with Director Glenn regarding this request and it would most likely be discretionary use and would require the standard two weeks to allow for feedback from the advertisement. This will be discussed further at the next Planning and Protective Services Committee meeting.



8. Councillor Street informed Council and residents that she attended a strategic planning workshop on July 23 with other members of Council and Senior Staff and there were a lot of great ideas discussed and information provided. She stated that it was great working with the departments and Council to help create a plan that will work for all residents and businesses within the Town.



 Councillor Street informed Council and residents that she attended the Sunsplash soccer tournament over the weekend and it was a very well organized event and she expressed her congratulations to all that were involved for a great tournament.



10. Councillor Martin discussed concerns regarding the mailboxes on Burnaby Street as they are on top of the curb and are a safety concern. He requested that the Planning and Protective Services Committee review the location of these mailboxes.



 Councillor Martin reminded Council and residents to keep grass clippings off the sidewalks and roads for the safety of cyclists and motorcycles.



12. Councillor Martin expressed concern regarding a construction worker walking in the roundabout without looking when crossing the street on Topsail Road/McNamara Drive. Mayor Bobbett responded that Director Milley will follow up with the contractor. Page 9

13. Councillor Martin is wondering when there will be an update on the construction on Topsail Road by McDonalds. CAO Niblock responded that they are working with the contractor to coordinate this work with the other construction that is taking place within the Town.



14. Councillor Martin wanted to thank staff for the work put into Neveah's Lemonade Stand. It was a great event. Deputy Mayor Laurie responded that she attended the event and there was over \$60,000 raised. Last year it was noted that Council would like to find a way to honour Neveah in Paradise Park and requested that it be revisited again.



15. Councillor Quilty informed Council and residents that she also attended Neveah's Lemonade Stand and it was an outstanding event.



16. Councillor Quilty expressed her appreciation to staff for putting together the Korean War Ceremony that took place on July 26. There was a great turnout for the ceremony.



17. Councillor Quilty provided a construction update.

### McNamara Drive

- The final lift of asphalt is being laid this week from the Town Hall to the end of the construction zone.
- The new roundabout is operating with a single lane during the remainder of construction. The traffic lights have been removed. During the day between the hours of 9am-4pm the area may revert to an intersection that is fully controlled by flagspeople but will operate as a roundabout during the evening commute. The next big piece of work will be to bring the whole area up to final subgrade before installing the curb.

# • Clearview Heights

The curb is starting to be placed and the last of the underground work is being completed.

## • Paradise Road

Work is progressing ahead of schedule. The road has been restored and the curb is being installed. The poor condition driving surface should now be behind us. There is a planned water outage in the area for tomorrow as a valve is being replaced.

- O'Brien's Way
  - o Construction is proceeding as planned.
- Lanark Drive Water and Sewer Truck Mains
  - The project will start within a month and will tie into the current work on Archibald Drive and Paradise Road.



- 18. Deputy Mayor Laurie informed Council and residents that she also attended the Korean War Ceremony and noted that the Town of Paradise is the only Community that has this ceremony annually. The Korean War Vets expressed their thanks to the Town Council and staff for their support each year.
- 19. Councillor English inquired about the sidewalk by McDonalds on Topsail Road. He understands the necessity of not tying up more traffic within the Town but would like to see this work completed in the fall.



20. Councillor English inquired about the development at the end of Christopher Street. The residents are expressing concerns because they don't see any movement with the development and there is not much progress. Mayor Bobbett responded that this will be discussed at the next Planning and Protective Services Committee meeting.



- 21. Councillor English noted that there was a significant traffic jam on the weekend on the Topsail Road/McNamara Drive roundabout. He asked if staff could look at having gravel added periodically on the weekends to keep the road in good order for better traffic flow.
