CAO Niblock stated that as of this afternoon the new pumps are operational and there are no trucks pumping from that location. Staff are continuing to monitor the situation 24 hours a day to ensure that there are no issues. The next step is to dry out the lift station so that the problem can be identified.



2. Deputy Mayor Laurie reminded residents about the 4 day garbage cycle that began today. The new schedule has been sent to residents and information can also be found on the Town's website, social media and the Town app - PingStreet.

3. Councillor Street asked about the news reports that stated that the Town has offered the resident on St. Thomas Line a rental property and asked why Councillors were not informed on this significant decision and wanted to know if this information was valid. Mayor Bobbett responded that his response to all media and residents is that a decision will be made by Council and proper protocol will be followed.



4. Councillor Street informed Council that she has received requests from residents asking that Council revisit reducing the speed limit on Topsail Road around Octagon Pond Elementary to 30 km. Mayor Bobbett responded that this would be brought back to Committee for discussion.



 Councillor Street acknowledged the passing of Ann Wiseman, the wife of former Mayor Ralph Wiseman and also the passing of Larry Dohey and passed along her condolences.



6. Councillor Quilty provided a construction update.

McNamara Drive:

The roundabout is now paved with base course asphalt. Traffic is flowing well with few interruptions. Work is now being completed on the splitter and centre islands. The project is expected to be complete in October.

Clearview Heights

The underground work is complete on Clearview Heights. They are now preparing for curb and gutter installation. Paving is expected in mid-September. Work is on schedule.

Paradise Road

The base course asphalt is complete except for the area of Camrose Drive and Archibald Drive due to coordination with the Lanark Drive Sanitary Sewer and Watermain Upgrades project. Crews are currently working on the sidewalks. The project is expected to be complete in September.

Lanark Drive Sanitary Sewer

Work is ongoing on undeveloped land near Adam's Pond. Work is expected to be complete in early November.

2018 Water and Sewer

The underground work is complete on O'Brien's Way. The road is open for traffic as the arch culvert is complete. Paving will be taking place in the coming weeks. The work on Pretty Place, Sullivan's Road and Brandywind Place are complete.

2019 Street Rehab

The patching on Kenmount Road and Evergreen Village is complete. Donna Road is stripped and paving is expected this week.
