#### 5. Municipal Plan and Regulations Policy Initiatives and Amendments

#### a. Commercial Vehicle Regulations Update

Committee discussed the Commercial Vehicle Regulations and recommend amending as proposed by staff.

#### a. Off Road Vehicle Presentation

#### 8. Planning and Development

#### a. 1297 Topsail Road – Seasonal Fenced Storage Area

Committee reviewed an application for a seasonal fenced storage area at 1297 Topsail Road and recommend approving the application subject to 3 conditions.

#### b. 6 Appleton Place – HBB Dog Grooming

The committee reviewed an application for a home based business at 6 Appleton Place and recommend proceeding with the Notice of Discretionary Use. It will be brought to Council for approval subject to 10 conditions and no objections being received in response to the Notice.

#### c. 27 Quilty's Road – Accessory Building (97m2) - DA

Committee reviewed an application for an accessory building at 27 Quilty's Road and recommended proceeding with the Notice of Discretionary Use.

It will be brought to Council for approval subject to 13 conditions and no objections being received in response to the Notice.

# d. Development Approval - Willowbanks Phase 3 - Gallants Street Extension

The committee reviewed an application for a development approval for Willowbanks Phase 3 and recommended Council approve with the subject to 21 conditions.

### e. Approval in Principle - Fairview Estates Phase 6B

Committee reviewed an application for Fairview Estates Phase 6B and recommend Council approve "in Principle" subject to 8 conditions.

### f. 1 Phoenix Drive – Fence Setback - DA

Committee reviewed a Development Approval for a fence setback at 1 Phoenix Drive and recommend proceeding with the public notice as per a newly established procedure for applicants proposing setbacks less than three metres. This will go to Council with the recommendation to approve subject to 4 conditions and no objections being received. This recommendation is made pending responses to referrals on the proposed fence location made to the Departments of Infrastructure and Engineering and Public Works.
