1. Safety Moment

Councillor Vaters brought forward a safety moment.

2. Delegation - Roy Locke, Mt Pearls Sports Alliance

Mr. Roy Locke gave an overview of the Mt. Pearl Sport Alliance. He advised that many of the athletes that are involved with the Sports Alliance are from Paradise. There are currently 13 sports involved and each sport is represented by a board member. He is asking Council to consider joining the Sports Alliance with Mt. Pearl to create one group.

Committee discussed the Football uprights. Football NL has decided not to proceed with the placement of the goal posts at Octagon Pond Elementary. Committee agreed the Town will not be responsible for storing the uprights.

d. Leo's Club

The Lions Club have reached out to discuss the possibility of extending the Leo's Club for youth in the Town of Paradise. A meeting room would be required to hold meetings between September to June. Committee were in support of this request. The Director advised that the rentals for

fall programs are currently being reviewed and confirmations are to be sent by the end of August, making space for a meeting area for the Leo's club.

e. Zamboni A Battery Replacement

Committee recommend that staff to proceed with the purchase of new batteries for Zamboni A, and the cost will be absorbed in the operational budget.
