

Re: Your request for access to information under Part II of the **Access to Information and Protection of Privacy Act**, **2015** [Our File # 2024-04]

On July 26, 2024, the Town of Paradise received your request for access to the following records/information:

Campaign contributions for those elected and acclaimed to the Town Council in 2017, 2021 and 2024 (by-election). This is for the position of Mayor and Councillor.

I am pleased to inform you that a decision has been made by the ATIPP Coordinator for the Town of Paradise to provide access to the requested records.

Access to some information contained within the records has been refused in accordance with the following exception(s) to disclosure, as specified in the Access to Information and Protection of Privacy Act, 2015 (the Act):

Disclosure harmful to personal privacy

40. (1) the head of a public body shall refuse to disclose personal information to an applicant where the disclosure would be an unreasonable invasion of a third party's personal privacy. Disclosure harmful to business interests of a third party

Please be advised that you may ask the Information and Privacy Commissioner to review the processing of your access request, as set out in section 42 of the Access to Information and Protection of Privacy Act, 2015 (the Act). 
