## ATIPP Response 2024-22

Paradise Road: Road Work Completed in 2019 and 2020

## 2019

- Paradise Road Phase 3: Work took place throughout the 2019 construction season (spring fall) to complete roadwork, sidewalks, and storm sewers on both sides of the road from Stormont Street to Archibald Drive. The contractor for this work was Fairview Investments.
- Paradise Road Phase 3: Work also took place related to the water and sewer trunk bypass project
  on Paradise Road. The area of work for this project was from Lanark Drive up Archibald Drive and to
  the intersection of Camrose Drive along Paradise Road. This took place throughout the 2019
  construction season (spring fall) and the contractor was Fairview Investments.

## 2020

- Paradise Road Phase 3: Phase 3 work continued during the 2020 season (spring fall) to finish the sidewalks and storm sewers on both sides of Paradise Road from Stormont Street to Archibald Drive. The contractor was Fairview Investments.
- Paradise Road Phase 4: This work was awarded in September 2020 and started shortly after. This
  portion of work included roadwork and sidewalks on both sides of Paradise Road from Archibald
  Drive to St. Thomas Line. This section of work started in 2020; however, the majority of the project
  took place in 2021-22. The contractor for Phase 4 was Modern Paving.
