Insufficient monthly withdrawal amounts will result in interest charges to your tax account and a Non-sufficient Fund (NSF) fee. *Please note: If you have more than one NSF payment you will be removed from Preauthorized Debit payment and you will have to make other arrangements to pay the remaining tax balance and all future taxes.*
